DRIVEWAY CONSTRUCTION DETAILED: Please use the back of this form or attach a sketch showing the location of the proposed driveway, any drainage facilities or features which may affect or alter any drainage, details as to how the driveway entrance is to be constructed or altered, including all materials to be used, finished grade and seeding of the sides of the driveway, temporary and permanent soil erosion control measures and materials for a distance of 50 feet from the centerline of the road and any other details which the township road supervisor or township engineer may request.

For a new driveway being cut, you must place a stake at each side of the proposed driveway with your name on the post to identify to the road department the exact location. **PLEASE NOTE:** the finished grade from the centerline of the roadway to a point 50 feet on the driveway shall not exceed 1%. No new driveway profile shall exceed 15% at any point.

All driveway entrance pipes shall be installed by the township road department. A minimum length of pipe to allow for sufficient flare is 32 feet. If you wish additional pipe, please specify in multiples of 8 feet. The township road supervisor shall determine the diameter of the pipe to be installed. After the installation of the pipe, you will be billed at a rate of \$ _____ per ton for stone, \$ _____ per foot for 15 inch pipe or \$ _____ per foot for 18 inch pipe.
