Mayor's Update

I appreciate the confidence that the Township Committee members showed by electing me Mayor and Dart Sageser, Deputy Mayor, I look forward to fulfilling my responsibilities as your Mayor. This is the beginning of my 4th year on the Township Committee, having been first appointed to fulfill the unexpired term of the prior Committee member, Pat Cregar. I want to acknowledge and thank the over 100 residents who have volunteered their time and talents to our committees and boards, resulting in lower taxes for all residents. I welcome the two new members of the Township Committee, Rick Wolfe and Kevin Ostrander, and look forward to working with the governing body on non-partisan decisions for all residents.

The New Jersey Division of Local Government Services sent a letter to the township concerning a complaint that had been made regarding the discrepancy between the 1998 referendum authoring the imposition of the Open Space Tax and the 1999 ordinance that implemented the tax. They acknowledged that they had the duty to investigate the claims that were made concerning the expenditure of money from this fund. They also acknowledged that an effort was made by municipal officials to quantify the expenditures and that the Township had moved to correct this situation through a referendum this past November that was approved by 73% of voters. They concluded by stating they would not require the current fund to re-instate any of the expenditures as this would create budget challenges that would negatively impact the taxpayers of East Amwell. The Township Committee considers this a closed case and thanks the voters for their support of the referendum reaffirming the Preservation Trust Fund.
