We had a big turnout for Roadside Cleanup Day – almost every road was spoken for! **THANK YOU** to all of our volunteers who participated and complied with our social-distancing guidelines; East Amwell is a beautiful place to live because of you!

**TREX PLASTIC PROGRAM**

As a result of the COVID-19 pandemic, our TREX plastic collection program has been put **ON HOLD until further notice**. Our drop-off store is currently NOT accepting TREX donations, therefore we cannot take any plastic at this time. Please hold plastic at home until further notice. **OPTIONAL:** If your grocery store is accepting plastic bags, you can drop off in their bin (usually at the front of the store) rather than putting in the waste stream.

With **STRICT ADHERENCE TO SOCIAL DISTANCING**  
we will be continuing with the following:

**MONTHLY RECYCLING DEPOT**  
**Sat. 2<sup>nd</sup> May (9am-Noon)**

The following rules will apply to the depot under the current Social Distancing guidelines:

- All recycling for the dumpsters must be brought to the depot in the trunk/rear **ONLY** of your vehicle.
- Residents **MUST STAY** in their vehicle while the volunteers remove the recyclables from the trunk/rear. If a resident wishes to handle this process themselves they need to let the volunteers know **FIRST**. The volunteers will then stand back while the resident does this alone.
- Anyone with Terracycling should (where possible) transport in the interior of their vehicle, drive over to the shed and deposit by the steps themselves.
- Reminder – no TREX will be accepted until further notice.
- VIPs will be available for pick up by the shed.
- All volunteers will be wearing gloves and masks.


