She also noted that Mr. Casella, teacher at East Amwell Township School won Most Valuable Teacher of the Month and then won Most Valuable Teacher of the Year in a contest sponsored by the NHL, winning a total of \$30,000 for East Amwell Township School.

Frances Gavigan – Ms. Gavigan asked what Ordinance 23-08 was about. Mr. DiPirro explained that it was a property tax mechanism called PILOT (Payment in Lieu of Taxes) where the municipality would net more funds than if normal property taxes were paid.

Mayor Casper-Bloom acknowledged DPW Superintendent, Jason Silverthorn, for designing a garden and placing a bench in Clawson Park in memory of former Township Clerk, Terri Stahl. She also thanked Sweet Valley Farms for donating all the plants for the garden.

Mayor Casper-Bloom also acknowledged the Ringoes Village Advisory Committee for the flags which they placed in Ringoes Village for Memorial Day. She commented that the Committee is looking for more volunteers to place the flags around town for July 4th. She also thanked The Grange for making a donation for additional flags.

Mayor Casper-Bloom stated she will be performing her first marriage ceremony as Mayor next week and is happy to marry any couple that would like to come before her.

Mayor Casper-Bloom asked the Township Committee if they would be in favor of giving the employees off for the Juneteenth holiday. She commented that New Jersey passed it as a State holiday in September of 2020 and the Federal Government passed it in June of 2021 as June 19th. The committee agreed to add Resolution 2023-104 to tonight's agenda to authorize Juneteenth as Township holiday.

Mayor Casper-Bloom explained that this ordinance is part of our capital budget to provide for DPW Equipment, repairs to Welisewitz Road, upgrades to security camera and repairs to various township roads.

Frances Gavigan – Ms. Gavigan asked if the Township Committee could give a breakdown of how the money is being spent. Ms. Giliberti responded that the breakdown amounted to \$50,000 for DPW Equipment and Vehicles, \$150,000 for repairs to Welisewitz Road, \$25,000 in security camera upgrades and \$100,000 for repairs to various township roads.

Joanne Engleman – Ms. Engleman asked where the money for this ordinance came from. Mayor Casper-Bloom explained that the funds came from the Capital Improvement Fund which is part of the budget.

There being no further comments, on motion made by Mr. Di Pirro, seconded by Mr. Mills and carried unanimously, it was moved to close the Public Hearing.
